Course Description:

This year's Cross-Cultural Women and gender History (CCWgH) course examines the history of youth and gender in the modern world. The global discourse on adolescence begins in earnest in the twentieth century. From G. Stanley Hall's groundbreaking psychological study of adolescence in the late nineteenth century to the role of the younger generations in the Arab Spring, teenagers and youth have often been the barometer of national cultures and crises. The fact that young people are often the first to embrace global trends adds to their problematization. We will discuss shifting theories of adolescence as a gendered social category, as well as the role of sexuality, politics, economics, and culture in the history of youth in the Americas, Europe, Africa, and Asia.

This year's Guest of Seminar will be Lynn Thomas, Professor and Chair of the Department of History at the University of Washington. During her visit on October 15th she will speak about her participation in the "Modern Girl Around the World" project resulting in the publication of *The Modern Girl Around the World: Modernity, Consumption, and Globalization* (Duke, 2008). She will also give a talk on her current research on Monday, October 15th at 12:00 p.m. in 2203 SSH.
